- Money laundering and online romance scam
- Targeted widowed and divorced women over 65
- Cost to victims more than 6 million, with some losing their entire life savings

- Started as a friend request on Facebook
 - Craving companionship
- Then money requests came in
 1,500 then 5,000 then 40,000
- Catfished for 17,000 by another scammer
 - Depleted savings, 2nd mortgage on home
- She got help and shared her story to help others

Utah Department of Health & Human Services

- Affinity fraud is a type of investment fraud in which a con artist targets members of an identifiable group based on things such as race, age, religion, etc.
 - Investment fraud involves complex financial crimes often characterized as low risk investments with guaranteed returns. Trust –based represent biggest portion of losses for investment in 2022.
- Romance/confidence fraud is where an individual believes they are in a relationship (family, friendly, or romantic) and are tricked into sending money, personal and financial information, or items of value to the perpetrator or to launder money or items to assist the perpetrator. This includes the Grandparent's scheme and any scheme in which the perpetrator preys on the complainant's 'heartstrings'.

Romance Scams and Affinity Fraud

FTC Elder Fraud Statistics – 2022 *Federal Trade Commission

- Seniors reported fraud less frequently than younger adults
- Older Adults age 70-79
 - 112.5 million loss to Business Imposters
 - 97.7 million loss to Miscellaneous Investments
 - 89.2 million loss to Romance Scams
- Top losses age 80+
 - 54.5 million loss to Prizes, Sweepstakes & Lotteries
 - Business 2nd, Romance 5th
- Primary method of contact for 70+, phone call



FBI IC3 Elder Fraud Report 2022

- Victims over 60 88,262
 - 3.1 billion total losses
 - 84% increase in losses from 2021
- Romance Scams Victims 7,166
- Over 60 victim losses
 - Investment scams \$990,235,119
 - Romance scams \$419,468,142
- Utah had 741 victims (#30), Utah's loss \$27,657,757 (#26)





Older adults who have been abused:

- 1) Have a 300% higher risk of death when compared to those who have not been mistreated
- 2) Report higher rates of depression
- 3) Withdraw from social interactions
- 4) Often blame themselves, resulting in shame and silence
- 5) Have higher rates of hospitalization and institutionalization

Vulnerability


- Cognitive issues associated with **aging**;
- Mild Cognitive Impairment (MCI): Doesn't interfere with daily life or function, but significantly impairs understanding financial concepts/ability to manage finances;
- □ Estimated that **15-20% of adults** over age 65 have MCI;
- Financial impairment is earliest sign of cognitive decline: someone functioning well overall may be impaired in this area.





RISK FACTORS

Recently bereaved Memory or cognitive issues Isolation or loneliness Others help with finances







- Ken Gardner Policy Institute 2021 Study showed that 1 in 4 women over the age of 18 in Utah are family caregivers
 - 450,000 adults in Utah provide unpaid caregiving services to their family and friends
 - About 30% of Utah's caregivers provide care for a parent; 16% provide for their spouse; 12% for their child; and almost half for another relative or family friend
- Utah Caregiver Support Program Survey identified that 69% of caregivers were women
- AARP study showed that 69% of caregivers were stressed due to their responsibilities



Cost of Financial Exploitation



- Cost of elder financial exploitation in Utah is \$92 million year
- 1 in 44 cases of financial exploitation are reported
- Estimated cost to banks: \$1 billion per year



Non-Financial Costs

Effects of financial exploitation:

- 19% evicted from home
- 10% turned to Medicaid
- 3x more likely to die





Mandatory Reporting Under Utah Law (UC §26B-6-201)

"Any person who has reason to believe that any vulnerable adult has been the subject of abuse, neglect, or exploitation shall immediately notify Adult Protective Services intake or the nearest law enforcement agency. When the initial report is made to law enforcement, law enforcement shall immediately notify Adult Protective Services intake. Adult Protective Services and law enforcement shall coordinate, as appropriate, their efforts to provide protection to the vulnerable adult."



Adult Protective Services (UC §62A-3-305(1))

- Adult Protective Services is the state agency responsible to investigate abuse, neglect, and exploitation of vulnerable adults and provide, where appropriate, short-term, limited protective services.
- Utah is a mandatory reporting state, meaning anyone who has reason to believe that a vulnerable adult has been the subject of abuse, neglect or exploitation shall immediately notify Adult Protective Services or Law Enforcement.

Vulnerable Adult

An elder adult, 65 years of age or older.



An **adult (18-64) who has a mental or physical impairment** which substantially affects that person's ability to:

1) Provide personal protection;

2) Provide necessities such as food, shelter, clothing or, mental or other health care;

3) Obtain services necessary for health, safety, or welfare;

4) Carry out the activities of daily living;

5) Manage the adult's own financial resources; or

6) Comprehend the nature and consequences of remaining in a situation of abuse, neglect, or exploitation.

Adult Protective Services

What APS Can Do:

□Investigate allegations of abuse, neglect and exploitation □Perform protective needs assessments Coordinate with, or make referrals to, community resources and services Provide short-term, limited services to a vulnerable adult when family or community resources are not available to provide for the protective needs of the vulnerable adult

What APS Cannot Do:

Enter an adult's home without consent
Take custody of an adult
Conduct welfare checks
Provide any service without voluntary consent of the victim, unless court ordered
Investigate if victim is deceased

Utah Department of Health & Human Services Aging & Adult Services

APS Intake Criteria

APS shall process all referrals with allegations of abuse, neglect, or exploitation of a vulnerable adult in the State of Utah:

- The APS Intake team will assess if the referral meets criteria for an investigation.
 - If the referral meets criteria, the case will be assigned an investigator who will meet with the vulnerable adult, investigate the allegations and offer appropriate resources.
 - If the referral does not meet criteria, the APS Intake team will offer appropriate resources to the person reporting that could assist/benefit the vulnerable adult.

APS does not accept referrals when:

- The referral involves an alleged financial scam and/or alleged consumer fraud.
- When the referral involves a vulnerable adult on an tribal lands.



Abuse, Neglect, Exploitation

In almost 60% of elder abuse and neglect incidents, the perpetrator is a family member. Two thirds of perpetrators are adult children or spouses. - NCOA

Utah APS Investigations FY23

APS investigated 4,087 cases of abuse, neglect, and exploitation of vulnerable adults.

- 59% female, 41% male
- 62% of allegations occurred in their own home
- 54% of alleged perpetrators were a family member or relative

Of those cases, 5,750 allegations were investigated, with the top three allegations being:

- 1523 Financial Exploitation
- 1176 Caretaker Neglect
- 1042 Emotional Abuse







Adult Protective Services supports selfdetermination, the right of an adult with decisionmaking capacity to make decisions for themselves, even if others feel the decision is not in their best interest.

If It Happens to You or Someone You Love

- It is normal to be hesitant about reporting abuse by a family member.
- Abuse, neglect and exploitation leads to increased anxiety, depression, severe stress, and sleep problems.
- You are not alone.
- Report, and get help!
